This scholarship will be awarded to a qualified student(s) who are planning to attend college after high school graduation. The number and amount of scholarships given is dependent on club resources. Applicants must, at a minimum, meet criteria listed below.

The scholarship committee reviews every submitted application and screens for those it wishes to interview in the selection process.

The criterion includes:

- 1) The Student has to have applied and/or been accepted to an accredited institution of higher education and plans to attend;**
- 2) The Student attends Clinton H.S. Camanche H.S., Prince of Peace H.S., Unity Christian H.S., Fulton, H.S., Northeast H.S., Clinton Community College*, or is a direct relative of an active Clinton Rotary member.**
- 3) The Student demonstrates financial need;**
- 4) The Student demonstrates academic achievement,**
- 5) The Student demonstrates the characteristics of good citizenship**

All applications need to be submitted by May 15 of the applicable year. The scholarships are awarded on or before July 1 of the applicable year. Awards are dependent on student's acceptance into an institution of higher education. You can download the application at www.rotaryclubofclinton.com
